REQUIREMENTS BY P.U.D. 3

(Applications take 2 to 8 weeks to process, depending upon complexity of job and current number of applications being processed)

- 1) Application for New Service.
- 2) Application Fee - \$100.00 for Single-Phase Service \$250.00 for Single Phase Developments and \$500.00 for all Three Phase Services. Application fees can be paid for with cash, check or Visa/Master Card. Application Fees are applied to the cost of the extension project that is carried forward to completion. NOTE: Application Fees are non-refundable.
- 3) Application for Credit (unless you have previously completed the Application for Credit with PUD 3).
- 4) Copy of Building Permit and Approval Number from the State Electrical Inspector are required, but not necessary to submit application for estimate.
- 5) Plot Plan of Development or Drawing of Property (Need location of septic, poles, mobile, home (entrance), and temporaries).
- 6) New Service Address prior to connection of power.
- 7) Copies of current recorded deed or current recorded contract of sale and parcel number for property.
- 8) Property corners clearly marked.
